

# **SEIGEL TENNIS POLICIES & REGISTRATION WAIVERS**

## **Cancellation Policy**

7 days or more before programme: If written notification is received 7 business days, or more, prior to the programme start date there is a full refund, less a \$50.00 fee.

Less than 7 days: If written notification is received less than 7 business days prior to the programme start date, no refund or credit will be issued.

Programme has ended: If written notification is received after the programme has ended, no refund or credit will be issued.

Programme is cancelled: If a registrant cannot be accommodated due to insufficient enrolment or we cancel your programme for other reasons, there will be a full refund. Transfers will be made wherever possible.

Participant is removed from the programme by the staff: If a participant is withdrawn by our staff due to programme incompatibility, there will be a pro-rated refund for the balance of the classes, less a \$50.00 fee.

## **Rain Policy: Spring Lessons**

All classes that are rained out will be made up at the end of the session. A class is officially deemed a rainout if less than 30 minutes are played.

## **Rules of Conduct**

If a child is physically or verbally abusive, Seigel Tennis has the right to remove this child from the lessons or camp.

Participants and guests are prohibited from taking photos or videos.

## **Information Policy**

If you participate in a league, your email address may be shared with other participants in that league.

## **RELEASE OF LIABILITY WAIVER**

In enrolling for programs offered by Seigel Tennis at O'Connor Hills Tennis Club, I, on behalf of myself and my family members, understand that those using and/or playing on the courts at O'Connor Hills Tennis Club, and the facilities next to the courts, including, but not limited to, the pool, playground, field, Broadlands Community Centre, and any other indoor facility, does so at his/her/their own risk.

I, on behalf of myself and my family members, assumes full responsibility for all injuries and/or damages which occur in or about any use of the premises and I, on behalf of myself and my family members, hereby fully and forever release, discharge and hold harmless Seigel Tennis and O'Connor Hills Tennis Club, all associated facilities and the owners, employees, volunteers, contractors and/or subcontractors, and agents, from any and all claims, demands, damages or rights of action, present or future, resulting from the participation of the above listed people in any programs or in or about any use of the premises at O'Connor Hills Tennis Club.

In addition, I, on behalf of myself and my family members, agree that we will follow the rules of conduct and play set by Seigel Tennis and O'Connor Hills Tennis Club and understands that failure to do so may result in suspension from participation.

I, on behalf of myself and my family members, also grant authority to the staff of Seigel Tennis at O'Connor Hills Tennis Club to render judgment, for me and my family members concerning medical assistance or hospital care in the event of an accident or illness.

The information requested on this form is for Club purposes and will be shared only with the North York Tennis Association, the Ontario Tennis Association and the City of Toronto according to their requirements.
